

RESOLUTION 09-06

A RESOLUTION OF THE ALEUTIANS EAST BOROUGH CERTIFYING THE REGULAR ELECTION RESULTS, CALLING FOR A SPECIAL ELECTION FOR THE PURPOSE OF RESOLVING A RUNOFF FOR ONE ASSEMBLY SEAT, TO APPOINT ELECTION JUDGES AND A CANVASS COMMITTEE.

WHEREAS, The Borough Clerk certifies that the election results of the October 7, 2008 Regular Election as attached are true and accurate, and

WHEREAS, Title 4, Sec. 4.04.070 requires in excess of 40% of the votes cast for the seats for which the candidates are running, and

WHEREAS, Aleutians East Borough Assembly Seat F candidates Paul Schaack and William Dushkin Sr. did not receive in excess of 40% of the votes cast in the October 7, 2008 regular election, and

WHEREAS, Title 4, Section 4.08.020 requires that the Assembly appoint at least three election judges for each designated polling place, and

WHEREAS, Title 4, Section 4.08.050 requires that the Assembly appoint a canvass committee to canvass all votes after the election judges tally.

NOW THEREFORE BE IT RESOLVED by the Borough Assembly:

1. That the regular election results presented by the Borough Clerk are approved.
2. On November 18, 2008, a special election to be held to resolve the issue between the candidates on the Assembly seat above.


4. The following serve as canvass committee to canvass all votes:

BE IT FURTHER RESOLVED BY THE ASSEMBLY OF THE ALEUTIANS EAST BOROUGH:

1. The above list of persons is appointed to serve in the November 18, 2008 special election.
2. They shall serve under the direction of the borough clerk to conduct the election and canvass in a proper manner.
3. Should they be unable to fulfill their duties, the borough clerk shall name an alternative.
4. The election judges shall be compensated at the rate of \$200.00 per day to perform all election duties.
5. The canvass committee shall be compensated at the rate of \$50.00 per day to canvass all the votes.
