**RESOLUTION No. 08-06**

**A RESOLUTION OF THE ALEUTIANS EAST BOROUGH IN SUPPORT OF THE ALASKA DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES' APPLICATION TO THE DENALI COMMISSION FOR COLD BAY ROAD IMPROVEMENTS ASSISTANCE.**

WHEREAS, the Alaska Department of Transportation (DOT) intends to submit a Denali Commission application for funding assistance for Cold Bay road improvements and has requested a letter or resolution of support; and

WHEREAS, the Aleutians East Borough has read and concurs with the recommendations of the Cold Bay Airport Terminal Area Redevelopment Plan Functional Flow Assessment report; and

WHEREAS, the previous named report, completed by Aries Consultants, Ltd. for the Alaska DOT, identifies the Cold Bay road improvements listed below; and

WHEREAS, the Aleutians East Borough Assembly agrees with the urgent need for the Cold Bay road improvements as listed below for safety reasons and to meet the any applicable requirements of the Federal Aviation Administration, Transportation Security Administration, Americans with Disabilities Act and to meet the work standards of the Alaska DOT in connection with roads linking the new airport terminal, the existing airport aprons and the hovercraft landing site.

NOW, THEREFORE, BE IT RESOLVED THAT the Aleutians East Borough hereby confirms its support for the Alaska DOT's application to the Denali Commission for funding to complete the following Cold Bay road improvement projects as recommended in the above cited report:

1. Install safety barrier along the side of Utech Hill.
2. Realign and reconstruct Utech Hill for line-of-sight, grade, width and slope stabilization.
3. Widen and upgrade Baranov Road.
4. Widen and upgrade Reeve Avenue.
5. Widen and upgrade perimeter road (St. Louis Road) between new passenger terminal and North Airport Apron.
6. Upgrade portions of Truesdale Street between Baranov Road and Reeve Avenue.

BE IT FURTHER RESOLVED THAT the Aleutians East Borough will provide a copy of this resolution to the Alaska DOT for their use as a demonstration of its support for their application to the Denali Commission.
