

Notice of Offices to be Filled for Oct. 2, 2012 Election

The regular Aleutians East Borough election will be held October 2, 2012. Declaration of Candidacy (DOC) must be filed with the Borough Clerk in Sand Point or with an Assistant Borough Clerk beginning **August 20 through August 31, 2012**. Forms are available at all locations.

Completed notarized forms must be received in person by the Clerk or Assistant Clerk. Faxed copies of signed Declaration of Candidacy will not be accepted as official notice of intent to file.

All Candidates must file a completed Public Official Financial Disclosure Statement. Copies are also available through the Clerk's office or an Assistant Clerk in your community.

Qualifications of Assembly and School Board Members: The Assembly and School Board Members shall be a qualified elector of the Aleutians East Borough and shall have been a resident within the Borough for a minimum of one year prior to holding office.

All Candidates Must File a Completed Public Official Financial Disclosure Statement.

No Declaration of Candidacy May be Accepted, Corrected, Amended or Withdrawn after 5 p.m. on Friday, August 31, 2012.
