

Re: Certification of the October 1, 2019 Regular Election and Resolution 20-30, calling for a run-off election, November 5, 2019.

This year's election was very interesting. One vote determined Carleen Hoblet receiving excess of 40% of the votes cast for School Board Seat G – the power of one vote! Since it was so close to being a run-off, the Canvass Committee did a full recount, of that seat.

The Assistant Clerks and judges appointed in all the AEB communities helped make this a successful election year, once again. They all are amazing and very professional, conducting the election around the region.

The results of the October 1, 2019 Regular Election are below:

Assembly Seats:

Seat B, three year term – No one received in excess of 40% of the votes cast. A run-off is necessary between Paul Gronholdt and Mikal McGlashan.

Seat E, three year term – Carol Foster

Seat G, three year term – Denise Mobeck

School Board Seats:


Seat B, three year term – Carla Chebetnoy

Seat E, three year term – No one received in excess of 40% of the votes cast. A run-off is necessary between Brenda Wilson and Rita Uttecht.

Seat G, three year term – Carleen Hoblet


373 Ballots cast.

4 Questioned ballots and by-mail ballots rejected.



RESOLUTION 20-30

A RESOLUTION OF THE ALEUTIANS EAST BOROUGH CALLING FOR A SPECIAL ELECTION FOR THE PURPOSE OF RESOLVING A RUN-OFF FOR ASSEMBLY SEAT B AND SCHOOL BOARD SEAT E AND TO APPOINT ELECTION JUDGES AND CANVASS COMMITTEE:

WHEREAS, Title 4, Sec. 4.04.070 requires in excess of 40% of the votes cast for the seat for which the candidates are running; and

WHEREAS, the Assembly Seat B candidates Paul R. Gronholdt and Mikal McGlashan neither received in excess of 40% of the votes cast in the October 1, 2019 Regular Election; and

WHEREAS, the School Board Seat E candidates Brenda Lee Wilson and Rita Uttecht neither received in excess of 40% of the votes cast in the October 1, 2019 Regular Election; and

WHEREAS, Title 4, Section 4.08.020 requires that the Assembly appoint at least three election judges for each designated polling place; and

WHEREAS, Title 4, Section 4.08.050 requires that the Assembly appoint a canvass committee to canvass all votes after the election judges tally.

NOW THEREFORE BE IT RESOLVED, by the Aleutians East Borough Assembly that:

1. On November 5, 2019 a Special Election be held to resolve a run-off between Assembly Seat B candidates, Paul R. Gronholdt and Mikal McGlashan; and resolve a run-off between School Board Seat E candidates, Brenda Lee Wilson and Rita Uttecht.
