



The results of the October 2, 2012 Regular Election is below:

Assembly Seats:

Seat C – Paul R. Gronholdt
Seat D – Brenda Lee Wilson

School Board Seats:

Seat A – Glen Gardner, Jr.
Seat F – Nikki Hoblet

There were 17 ballots not counted. Seven of the absentee by-mail ballots did not complete the voter certification envelope properly. Ten question ballots were not considered because two registered too late, one not registered, one registered outside AEB and one inactive/felon. Akutan's absentee ballots (4) and question ballots (5) were not counted since they had not arrived to be reviewed by the Canvass Committee. Akutan's absentee and question ballots would not have changed the results of the election.
