

## Ordinance No. 08-07

## AN ORDINANCE ADOPTING THE FINAL PLAN AMENDMENT OF THE ALEUTIANS EAST BOROUGH COASTAL MANAGEMENT PLAN

WHEREAS, the original Aleutians East Borough Coastal Management Plan was adopted in 1989; and

WHEREAS, the Aleutians East Borough Coastal Management Plan has been amended in accordance with the revised Alaska Coastal Management Program (ACMP) statutes AS 46.39 and AS 46.40 and the new ACMP regulations at 11 AAC110, 11 AAC112, and 11 AAC 114; and

WHEREAS, the Aleutians East Borough Assembly passed Resolution 08-01 supporting the revised Aleutians East Borough Coastal Management Plan; and

WHEREAS, the plan will guide the Aleutians East Borough's participation in the ACMP, a voluntary state program for the cooperative management of uses and activities in the coastal zone; and

WHEREAS, the Aleutians East Borough circulated the draft plan amendment for public review and comment in accordance with state law at 11AAC 114.345; and

WHEREAS, the Aleutians East Borough considered all comments received during the public review and comment period, and incorporated any necessary changes into the draft plan amendment; and

WHEREAS, the federal Office of Ocean and Coastal Resource Management has approved the revised Aleutians East Borough Coastal Management Plan;

## BE IT ORDAINED BY THE ASSEMBLY OF ALEUTIANS EAST BOROUGH

- Section 1. <u>Classification</u> This is a non-code ordinance.
- Section 2. Severability If any provision of this ordinance or its application to any person or circumstances is held invalid, the remainder of this ordinance and the application to other persons or circumstances shall not be affected thereby.

- Section 3. Action This ordinance adopts the 2006 Final Plan Amendment to the Aleutians East Borough Coastal Management Plan, a copy of which is attached hereto, as required by the State of Alaska, Department of Natural Resources, Office of Project Management and Permitting, Alaska Coastal Management Program to incorporate changes required by Alaska House Bill 391 and associated executive orders, statutes and regulations. The adopted plan completely replaces the current version of the Aleutians East Borough Coastal Management Plan.
- Section 4. <u>Effective Date</u> This ordinance shall be effective upon adoption by the Aleutians East Borough Assembly. The Aleutians East Borough Coastal Management Plan shall be effective thirty days after it is filed with the Office of the Lieutenant Governor.
