ADOPTION OF THE AGENDA

Hearing no changes or additions, the agenda will stand as written. CHRIS makes a motion second by JOSEPHINE

COMMUNITY ROLL CALL AND PUBLIC COMMENTS ON AGENDA ITEMS

The communities of King Cove, Sand Point, Akutan, Cold Bay, False Pass, Nelson Lagoon and the Anchorage office were participating by teleconference. Also broadcast on KSDP radio. There were no public comments.

CONFLICT OF INTEREST

Mayor Osterback asked for any potential **Conflict of Interests** to discuss. There were no conflicts on agenda items.

PRESENTATIONS

Trident Seafoods, Shannon Carroll and Dave Abassian

Carroll said Trident is still requiring full vaccination and this year requiring up-to-date with vaccinations, really appreciate the relationship with Eastern Aleutian Tribes. Will have enhanced visitation and onsite protocol given the speed of this variant is spreading. Trident has been working with their trade association to respond to a recent emergency rule request that has the potential to shut down the Bering Sea Pollock Fishery over salmon bycatch, this would have an impact on the Akutan and Sand Point operations. For the Board of Fish, we worked with Silver Bay to submit a letter requesting that the ACR that was passed through Chignik would be moved to not conflict with cod fishing. Trident had a 100-acre farm approved for kelp operations, but have no immediate plans.

Abassian said they are currently staffing the plants. The Akutan plant is currently running cod and the Sand Point plant is getting ready for the crab fisheries. Planning to support the fleet in the Gulf of Alaska in various fisheries, staying in close communication. The summer 2021 season was done a little differently than normal, and planning to do the same for 2022 season.

JOSEPHINE asked if Trident was looking at an open date for any of the community. Abassian said until numbers come down the doors will probably stay closed.

JOSEPHINE asked if the gym will be open to the public, Carroll said he will check into it.

PAUL asked what are plans for the Sand Point plant. Abassian said they are planning to operate it the same as last year and the fishermen will be supported.

Silver Bay Seafoods, Abby Fredricks

The 2021 season was a success with the team being fully vaccinated and had very low case count detected for COVID. Silver Bay is following the changing guidance for the virus, vaccines seem to be the key. We are going into our fourth year of operating in False Pass. The company has decided to put a pause on whitefish for 2022. Similar to 2021, we will continue to buy salmon. Making additional investments for the company including a new tender, the Steelhead, this boat has a very shallow draft, really easy to maneuver and can access the dock very well so it is perfect for the area. We are looking forward to being partner in the region for years to come.

TOM asked if whitefish is coming into the community for this year. Fredricks said that there is a pause for 2022.

Peter Pan Seafoods, Steve Minor

Peter Pan was acquired by new ownership a year ago, we have a strong Alaska component in the new ownership. Most of our focus right now is on marketing and value-added production. In order to work for PPSF, one must be fully vaccinated. We are still operating on a closed campus, which isn't changing anytime soon. We recently withdrew from the Boston Seafood Showing because we don't want to put our staff and vendors at risk with COVID still being widely spread. Our next biggest challenge will be the March Board of Fish. We plan to stay open for this season, though the decline in Bering Sea Crab is not helpful.

Natural Resources Director Weiss said thank you to all three of the processors, they work well with the fishermen, we appreciate it.

Mayor Osterback said thank you to all three processors. The Borough will be working with all of the processors to support all the protection of our fisheries in the Gulf and the Bering Sea as we move through the issues before us.

Eastern Aleutian Tribes, Paul Mueller

First would like to take all three of the processors. Mueller said we work well with the processors, EAT vaccinates as soon as they can. Omicron is running around and is more transmissible than the other variants combined, it is more mild effects, but it within nine days, EAT had two medivacs with the Omicron variant. Mueller says to follow the mitigation measures, get vaccinated, wear a mask, social distance and keep your social bubble small. Testing has increased expediential, starting to send down at home test for people to use if the clinics are closed.

Administrator Bailey said in June 2004 the Department of Natural Resources issued an easement decision to approve installation of two hovercraft landing terminals and segment of public access road over state tide and submerge lands underlying Cold Bay on the southern end of the Alaska Peninsula. The easement is approximately 12,000 feet in length and a variable width for a total of 7.63 acres or less. The First amendment was done in 2005 and the second in 2018. In 2019, the survey was completed as part of the requirements of the State. The State has provided the Borough a copy of the survey as well as the final easement document for ADL 228613.

Administrator's Report in packet. Highlights below:

CARES Act Funding Update:

The Borough received approximately \$3.7 million. Expended \$3.6 million by December 31, 2021. Remaining Invoices are anticipated to cover the remaining balance.

COVID-19 Funding Update:

In September 2021, the Borough received \$324,086.50 in ARPA/SALT funds. The second Tranche of the funds will be received in September 2022 in the amount of \$325.086.50. The full amount must be expended by December 31, 2024.

Cold Bay Terminal:

Work is progressing well, crew arrived back in Cold Bay, and interior slab was poured. Project is till scheduled to complete in January 2022.

King Cove Road Update:

9th Circuit Appeal: A decision on this case is still pending. Secretary Haaland's visit to King Cove is rescheduled sometime in early 2022. No response has been received from USFWS to the Stat DOT/PF administrative appeal that was filed. King Cove attorneys are trying to determine the next step in this appeal process.

Akun Dock and Breakwater Update:

One proposal was received for RFP on the due date. Mac Enterprises was selected and a fully time charter agreement was executed last December.

Sand Point and Akutan Harbor Floats Update:

On December 23, 2021, the PIDP grant awards were announced. Unfortunately, the Borough's grant application was not selected to receive an award. Administration will follow up with PIDP to schedule a debrief meeting to review the application. Letters were sent to Representative Edgmon and Senator Hoffman requesting to fully support funding the Borough's Sand Point Harbor State harbor Facility Grant request.

Financial Software Update:

A Request for Proposal has been issued Proposals are due on January 20, 2022.

Day to Day operations continues.

Alaska Board of Fisheries:

Southeast Yakutat meeting was postposed and was moved in Anchorage this March 10-22. Hatchery Meeting will be on the 23 and Statewide Shellfish meeting where they will hear the proposal 282 which is a transcription of ACR 7, supposedly March 26-April 2nd but that date is tentative. Board of Fish is down a member and Governor is to appoint a new member.

Alaska Board of Game:

Meeting is set in January 21-29 in Wasilla to consider South Central and SW Alaska game proposals, including for game management units 9 & 10 in our region. 19 Emperor Geese proposals, 1 from Alaska Migratory Bird Co Management Council that wants to take the right of non-residents to hunt Emperor Geese. All the others would provide increased opportunity for nonresident Emperor Geese hunting. The City of Cold Bay is on record supporting increased non-resident opportunity.

North Pacific Fishery Management Council:

The NPFMC will hold the February meeting once again in an online-only format. April meeting is scheduled in person. The Council took final action in December on the BSAI halibut abundance-based management and on BSAI and GOA groundfish specifications

AEB Fishermen's End of the Year Meeting:

The December 29th meeting was held via Zoom and was broadcast on KSDP.

Chinook Salmon Bycatch:

Several groups from the AYK region submitted an emergency petition to the Secretary of Commerce requesting an elimination of all Chinook salmon bycatch in the Bering Sea Pollock fishery. This would essentially close the BSAI Pollock fishery. We are working on our response and reaching out to other groups in our region to continue to support reasonable and sustainable Pollock fishery management.
