

RESOLUTION 10-05

A RESOLUTION OF THE ALEUTIANS EAST BOROUGH CALLING FOR A SPECIAL ELECTION FOR THE PURPOSE OF RESOLVING A RUNOFF FOR ASSEMBLY SEAT C AND TO APPOINT ELECTION JUDGES AND A CANVASS COMMITTEE:

WHEREAS, Title 4, Sec. 4.04.070 requires in excess of 40% of the votes cast for the seat for which the candidates are running; and

WHEREAS, the Assembly Seat C candidates Paul Gronholdt, Brenda Wilson and Dick Jacobsen neither received in excess of 40% of the votes cast in the October 6, 2009 regular election; and

WHEREAS, the candidates receiving the second highest votes, Brenda Wilson and Dick Jacobsen, both received the exact number of votes cast; and

WHEREAS, after a total recount both candidates agreed to a coin flip to determine the runoff candidate; and

WHEREAS, Title 4, Section 4.08.020 requires that the Assembly appoint at least three election judges for each designated polling place; and

WHEREAS, Title 4, Section 4.08.050 requires that the Assembly appoint a canvass committee to canvass all votes after the election judges tally.

NOW THEREFORE BE IT RESOLVED, by the borough assembly that:

- 1. On November 10, 2009 a special election be held to resolve the issue between Assembly Seat C candidates, Paul Gronholdt and Brenda Wilson.

- 1. The above list of persons is appointed to serve in the November 10, 2009 special election.
- 2. They shall serve under the direction of the borough clerk to conduct the election in a proper manner.
- 3. Should they be unable to fulfill their duties, the borough clerk shall name an alternative.
- 4. The election judges shall be compensated at the rate of \$200.00 per day to perform all election duties.
- 5. The canvass committee shall be compensated at the rate of \$50.00 per day to canvass all the votes.
