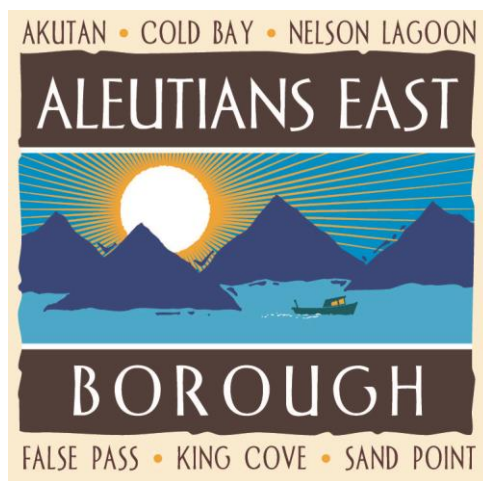


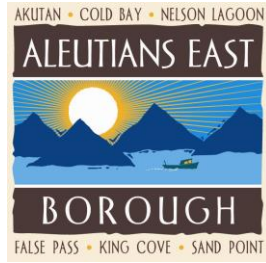

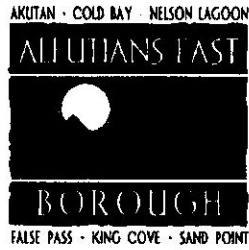

Everything went well during the November 8, 2016 Special Election. Good turnout by conducting the run-off election during the State election. The run-off election only had 21 less votes cast than the regular election.

The results of the November 8, 2016 Special Election is below:

Eight question ballots did not qualify. Three were not registered and five were not registered in Aleutians East Borough. Also, two absentee ballots by-mail did not get counted, the identification envelope was not signed or witnessed by two.

The Canvass Committee of the Aleutians East Borough, appointed by the Borough Assembly, met at 10:00 a.m. on November 14, 2016 for the purpose of canvassing the November 8, 2016 Special Election. The following are the results of the canvass:

342 Ballots cast.  
39 Absentee ballots counted (also includes by-mail & personal representative ballots).  
1 Questioned ballots counted.  
382 TOTAL BALLOTS COUNTED.  
10 Questioned ballots and by-mail ballots rejected.

339 REGISTERED VOTERS, 125 ballots = 36%

**NELSON LAGOON**

43 REGISTERED VOTERS, 12 ballots = 27%

**SAND POINT (includes 12 absentee ballots)**

437 REGISTERED VOTERS, 164 ballots = 37%

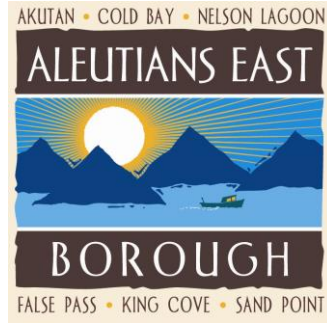
**ALEUTIANS EAST BOROUGH VOTING PERCENTAGE**
