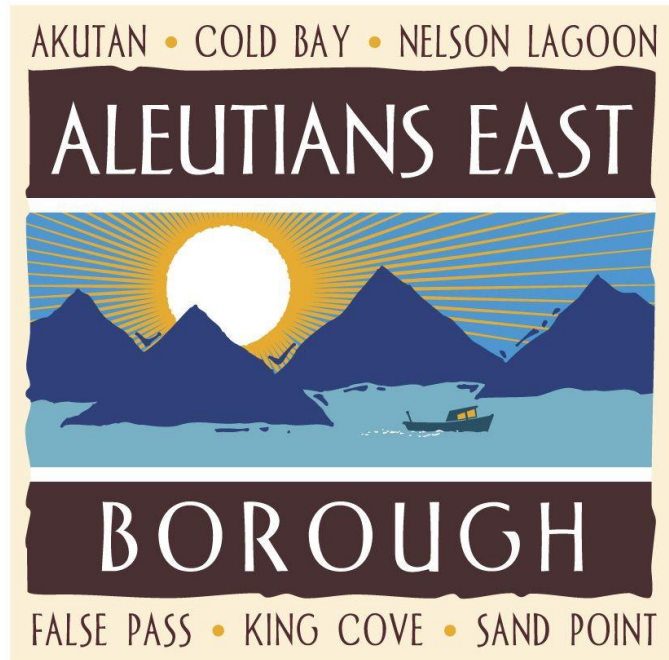

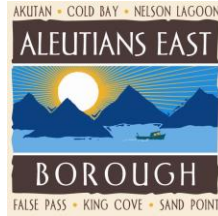

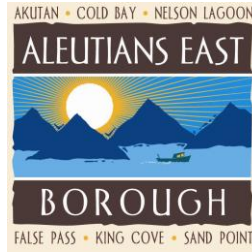

Re: Certification of the October 4, 2022 Regular Election

Due to the pandemic still on going, Early Voting polling location was established in Akutan to allow registered voters to vote two weeks prior to Election Day, which spread out the voters up until Election Day. Because of the close count for both Assembly Seat E and Assembly Seat G, the Canvass Committee did a full recount on that seat.

The Assistant Clerks and election workers appointed in all the AEB communities helped make this a successful and safe election year. They all were amazing and very professional, conducting the election around the region, keeping themselves and the public safe.

The results of the October 4, 2022 Regular Election are below:

Assembly Seats:

Seat B, 3-Year Term: Paul Gronholdt

Seat E 3-Year Term: No one received in excess of 40% of the votes cast. A run-off is necessary between Joseph Bereskin and Jim R. Smith Sr.

Seat G 3-Year Term: No one received in excess of 40% of the votes cast. A run-off is necessary between Dennis McGlashan Jr. and Dailey J.N. Schaack

School Board Seats:

Seat B, 3-Year Term: Brenda Lee Wilson

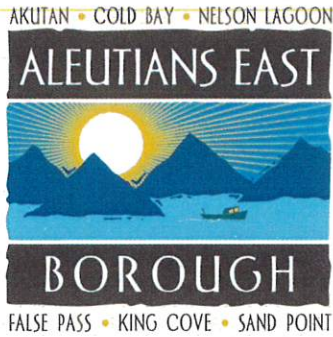
Seat D, 1-Year Term: Jade Gundersen

Seat E, 3-Year Term: Rita Uttecht

Seat G, 3-Year Term: Carleen Hoblet

Following is the 2022 Regular Election Results, Canvass Committee Report, and Voting Percentages by community. Once the election is certified, terms of office begin, for those elected, on the first Monday following the certification.

The Canvass Committee of the Aleutians East Borough, appointed by the Borough Assembly, met at 10:30 a.m. on October 14 for the purpose of canvassing the October 4, 2022 Regular Election. The following are the results of the canvass:

245 Ballots cast on Election Day.

95 Early Voting and Absentee ballots counted (includes by-mail communities and Special Needs).

2 Questioned ballots

362 TOTAL BALLOTS COUNTED.

3 Questioned ballots and by-mail ballots rejected.

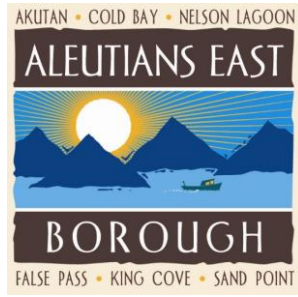

RESOLUTION 23-21

A RESOLUTION OF THE ALEUTIANS EAST BOROUGH ASSEMBLY CALLING FOR A SPECIAL ELECTION FOR THE PURPOSE OF RESOLVING A RUN-OFF FOR ASSEMBLY SEAT E AND SEAT G AND TO APPOINT ELECTION JUDGES AND CANVASS COMMITTEE

WHEREAS, Title 4, Sec 4.04.070 requires in excess of 40% of the votes cast for the seat for which the candidates are running; and

WHEREAS, the Assembly Seat E candidates Joseph Bereskin and Jim R. Smith Sr. neither received in excess of 40% of the votes cast in the October 4, 2022 Regular Election; and

WHEREAS, the Assembly Seat G candidates Dennis McGlashan Jr. and Dailey J.N. Schaack neither received in excess of 40% of the votes cast in the October 4, 2022 Regular Election; and

WHEREAS, Title 4, Section 4.08.020 requires that the Assembly to appoint at least three election judges for each of the designated polling places; and

WHEREAS, Title 4, Section 4.08.050 requires that the Assembly appoint a canvass committee to canvass all votes after the election judges tally.

NOW THEREFORE BE IT RESOLVED, by the Aleutians East Borough Assembly that:

1. On November 8, 2022 a Special Election be held to resolve a run-off between Assembly Seat E candidates , Joseph Bereskin and Jim R. Smith Sr. and resolve a run-ff between Assembly Seat G candidates, Dennis McGlashan Jr. and Dailey J.N. Schaack.

1. The above list of people is appointed to serve in the November 8, 2022 Special Election.
2. They shall serve under the direction of the Borough Clerk to conduct the election in a proper manner.
3. Should they be unable to fulfill their duties, the Borough Clerk shall name an alternative.
4. The election judges shall be compensated at the rate of \$200.00 per day to perform all election duties.
5. The canvass committee shall be compensated at the rate of \$50.00 per day to canvass all the votes.

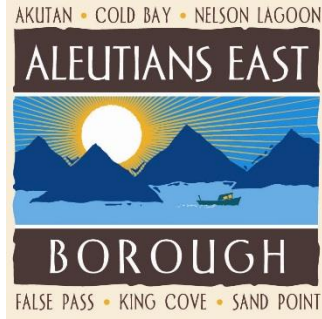
