NOAA's Alaska Region welcomes a new expert to foster understanding of tribal perspectives and improve working relationships and trust between agency staff and Alaska Native communities.

NOAA Fisheries' Alaska Region has selected Amilee Wilson as their new Tribal Relations Coordinator. Amilee previously served as the Tribal Coordinator for the NOAA Fisheries West Coast Regional Office in Lacey, Washington, and Portland, Oregon. She worked extensively on grants administration including emergency fisheries funding associated with the

Coronavirus Aid, Relief, and Economic Security (CARES) Act and Consolidated Appropriations Act. Amilee was a recipient of the 2022 NOAA Administrator's Award for her exemplary work on CARES Act implementation. As the Tribal Coordinator for the West Coast Region, Amilee revamped the Tribal Relations Training Program. She also served as a founding member and Co-Chair of the NOAA Native American/Alaska Native Employee Resource Group. She was often consulted as an expert to assist with tribal relations issues across the agency. Amilee has more than 25 years of experience working with Native American Tribes in the private, state, and federal sectors. She has gained extensive knowledge and experience with tribal histories, treaties, sovereignties, self-governance, protocols, customs, and traditions.
