





Community Information

1. What are the community's top goals and/or vision?

- Akutan
 - Fisheries
 - Completing capital projects
- Cold Bay
 - Purchase a backup generator for the water plant. At this time, the City does not have a backup generator for the water plant nor any of the city buildings.
 - Are also looking to purchase City Equipment Loader, Bobcat and city vehicles.
- False Pass
 - Fisheries
 - Completing capital projects
- King Cove
 - To maintain the communities economic/fisheries base and strengthen and expand existing infrastructure and services for the betterment of citizens lives' and to strengthen the base from which economic activities and development are performed.
- Sand Point
 - To have a safe, prosperous fishing community with the infrastructure and services to support the community.



2. How is/was the community impacted by the fishing season, and the State budget?

Akutan

- There is a decrease in public service offerings to all departments of government due to anticipated lower than previous years' fishing income and state budget cuts for services from the DCCED and capital improvement funding.

Cold Bay

- The community was impacted by the fishing season, since less people traveled through Cold Bay resulting in a loss for local businesses.

King Cove

- Fisheries Salmon and bottom-fish harvest/tax revenues for the past few years have been good. The current concern (fear) is what is occurring with Bristol Bay red king crab and Bering Sea snow crab harvests. The City anticipates a FY23 loss of these fish taxes of ~\$400K-\$500K of their annual, local fish taxes of ~\$1.2 million. This will be significant to King Cove but the hope is to recover a portion of these losses from the recently approved \$300 million federal disaster funds. The City is now taking a conservative approach to their spending, particularly for capital projects.
- State The State's budget has not had a major/significant impact on King Cove; however, the City still advocates for the PCE being compatible with renewable energy.

Sand Point

- Fisheries - Reduced June fishing resulted in lower raw fish and sales tax compared to years past. The limited capital budget the past years has resulted in projects going unfunded.



3. What are the most critical issues or challenges that you face in the immediate future (2023-2026)?

Akutan

- Any loss in Raw Fish Tax revenue and/or Alaska Shared Fisheries Business Tax revenue will require additional cuts to operational funding and services to the community.

Cold Bay

- PFAS Water Issue At this time both of the city wells are above the DEC action level of 70 PPT.
- Lack of a public school in Cold Bay.
- City roads are in poor condition.

False Pass

- Projects: Airport improvements and harbor house completion.
- Grant Writing

King Cove

- Crab Harvests
- Board of Fish and the impact of city revenues and local fishermen/family incomes
- Lack of qualified personnel for numerous city positions, poor transportation options to and from the City/Region, lack of mail service, the ongoing "tripledemic" and its effects on employee attendance, aging infrastructure and constantly dealing with extreme weather conditions.
- The ROAD

Sand Point

- Threat to fisheries in terms of openers and quotas, declining raw fish tax, infrastructure needs in the community.



4. What projects/community needs are you hoping to accomplish in 2023-2024?

Akutan

- Harbor Access Road & Harbor Float System; Replacement of our Health Clinic or expansion of the existing clinic facilities; Develop Sewer and Water Distribution Lines Replacement Plan; Update Harbor Operations and Harbormaster Training Plan; Update Economic Development Planning; Improve Akutan's and Akun's Broadband Access and Improve Akutan's Cable Utility Service Distribution.



- Both the City buildings are in need of foundation repair.
- Build a facility to house City equipment and for rental space.

False Pass

- Harbor House Construction; Income Survey for False Pass; Wastewater System Upgrades; Water Utility Design and Hydrology Analysis and Feasibility Assessments



- Refurbishment of the City's Old School, Reconstruction of West Lagoon Road; Expansion of Delta Creek well field; Construction of a Solid Waste Sorting Facility; Water System Upgrades; Harbor Master Plan and Harbor Utility Extensions and Facility Upgrades. This City is also conducting additional work with PCE, City Streets, Sewer Infrastructure and the Airport

Sand Point

- Replace burn box
- Repair bridges
- Begin engineering work on replacement of the dam
